

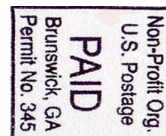

- February 12** Entries must be post marked by this date.
- March 10** Notification mailed by Glynn Art Association.
- March 26** Shipped work arrives.
- March 27** If hand delivered, drop-off time: 2:00-5:00 PM
- April 1** Artists' Reception and Awards Ceremony 5:00 - 7:00 PM
- May 1** Exhibition closes.
- May 3** Pick up of hand-delivered work. All work not picked up is subject to a late pick up/storage fee.
- May 4** Shipped work to be returned.

Dee Beard Dean

Dee is a passionate and prolific artist who is nationally recognized for her painterly landscapes and expertise in many media including watercolors, oils, and pastels. Her greatest inspirations have come from painting *en plein air* (or on location) where her eye for color and composition, and her elevated senses, guide her hand in creating paintings filled with evocative light and dramatic shadows. Ms. Dean has studied at Scottsdale Art School, Fechin Institute, New York Academy of Art, Grand Rapids College, and Kendall College. She has studied with many renowned artists.

Dee founded the Plein Air Painters of the Southeast (PAP-SE) which is acclaimed for plein air artists living and working in the southeastern United States. Dee has received many awards and has been published in regional and national journals. Her first book is in publication.

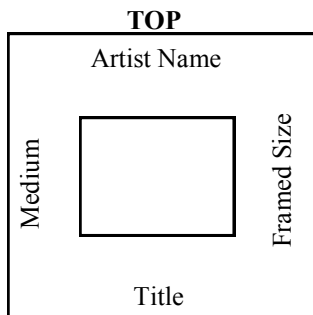
Eligibility: All artists, 18 years and older, are eligible to submit original paintings, pastels, drawings, mixed-media, and sculpture (no computer enhanced or work done in the classroom will be admitted). All work must be for sale and priced with intent to sell. The jurying of the show will be done by slides or CD and must accurately represent works entered.

Specifications/ Limitations: Only work that has not been previously exhibited or displayed at the Glynn Art Association will be eligible. Work must have been created within the past two years. Paintings must be quality framed and wired for hanging. Work must not exceed 4 feet in any direction and 50 pounds in weight. Use plexiglass on shipped work. No wooden shipping crates. Hand-delivered work may use glass.

Entry and fees: A non-refundable entry fee of \$35.00 enables the artist to submit three works. Submission does not guarantee acceptance. Check should be made payable to Glynn Art Association.

Digital Image Specifications (preferred submission): Digital images submitted on CD and must be in Jpeg File format - 300 dpi (5x7 inches). Each image file must have a file name: your last name, first initial_ entry #.jpeg. (For ex: smith_m_1.jpg) No email submissions. If you want your disk returned, send a self addressed, stamped envelope and label your CD with name, entry #, title, medium and size.

Slides Specifications: Submit up to three 35mm slides in standard mounts (no glass). Slides must be clearly labeled with the artist name, title, medium and size. (As shown below.)



Delivery & Shipping: Shipped works must be sent prepaid in a sturdy reusable carton. It must also contain a prepaid method of return.

Prizes and Awards:

\$1500 in cash and prizes will be awarded. Cash awards will be given to First, Second, and Third Place. **\$500.00** will be awarded to Best In Show. Honorable mentions will be awarded at the discretion of the Judge.

Liability:

All work will be handled with the utmost care by the art association staff. Glynn Art Association will not accept responsibility for loss or damage, including work enroute. It is advisable to provide your own insurance for artwork. Submission of an entry shall indicate agreement by the artist to these conditions.

Commissions, Sales and Reproductions:

Artwork sales will be encouraged, and therefore all artwork must be available for sale. The Glynn Art Association will retain a commission of **35%** of the sale price. Price your artwork accordingly. Payment to the artist will be mailed within 30 days of receipt of proceeds from sales. Glynn Art Association reserves the right to photograph and / or reproduce accepted entries for publicity and promotional purposes.
