## Gallery Jury Process

Dear Artist,

We are pleased that you are interested in being juried into the Glynn Art Gallery. There are several criteria for this process.

1. Three pieces of artwork in each media that the artist wishes to display in the gallery must be juried. Two-dimensional artwork must be framed and ready to hang to be juried. Size limited to 24x36 inches per pieces. Three-dimensional artwork must be presented as it would show in the gallery.
2. Your work must be for sale at an appropriate price.
3. Artwork must have been completed in the past year.
4. Artist must have a current typed biography and/or resume when submitting the application.
5. There is a six month waiting period before an artist can reapply if he/she fails to meet the criteria of the gallery.

**Artist** submitting artwork certifies that he/she is the sole proprietor of all rights in and to the works, and that the works are wholly original, are not derived in whole or in part from any pre-existing work, and were created by the **Artist**. **Artist** further certifies that to the best of the artist's knowledge, the works do not infringe on any rights, including without limitation, any copyrights, trademark rights, rights of publicity, or proprietary rights, of any other individual or entity.

Artwork critique will include: technique, strength, design and composition, content, and presentation.

## **Jury Committee Criteria**

### **Artist Requirements:**

- Work must be for sale at an appropriate price.
- Work must have been completed within the past year.
- Artist to provide a biography/resume when submitting three pieces of art to be juried.

**If the applicant fails to meet the criteria he/she must wait 6 months before re-applying.**

### **Criteria for Art Work:**

Technique – effective use of medium.

Strength of design and composition

- Does the work contain a range of values?
- Is there a good use of color?
- Are the colors harmonious and do they convey a mood?
- Is the use of light and shadow effective?
- Does the picture have depth?

Content

- Originality of composition is necessary
- Does the work have an initial effect?
- Does the work involve and stimulate the viewer?

Presentation

- Materials must be archival.
- Frames and mats must be in good condition and enhance the work.
- Work must be ready to hang with wire.
- Each work must be titled, priced and labeled on the back.
- The gallery may not accept subject matter deemed inappropriate.

The Glynn Art “Jury Committee” will consist of three professional artists in each media. They will serve a two-year term.

- Criteria Scale:
- 4 (excels criteria)
  - 3 (passed criteria)
  - 2 (needs work and further instruction)
  - 1 (fails to meet criteria)

## **Jury Application**

### **Artist Requirements:**

#### **Two Dimensional**

1. Three framed originals ready to hang with wire.
2. Limited to 24x36 inches per piece.
3. Each piece must be labeled on the back with title, medium, price, and name of artist.

#### **Three Dimensional**

1. Three pieces of work.
2. Each piece must be identified with title, medium, price, and name of artist.

### **Criteria:**

1. **Work must have been completed within the past year.**
2. **Artist must submit a resume/biography.**
3. **Artist must certify that he/she is the sole proprietor of all rights in and to the works. Work is wholly original and not derived from a pre-existing work and was created by the Artist. Works do not infringe any rights, copyrights, trademark rights, rights of publicity, or proprietary rights of any other individual or entity.**
